

CONTEST « Food preservation day »

Rules of participation

This contest is organized by Earth Day Canada as part of The Travelling Jar and will run from July 5th to October 8th, midnight. Five winners will be drawn. The draw will take place on October 10th, the winners will be contacted privately and will receive a \$570 conservation kit.

The "Canning Day" Contest (the "**Contest**") is being run solely on the @jourdelaterreqc Facebook page and the @jourdelaterreca Instagram page, a collaboration between Earth Day Canada (the "**Contest Organizer**") and Sobeys Capital Inc as the **Price Provider**.

The Contest runs on The Travelling Jar's website from July 5th, 2023 at 9:00 a.m. Eastern Time (ET) to October 8, 2023 by 11:59 p.m. ET (the "**Contest Period**").

ELIGIBILITY

The Contest is open to all legal residents of Quebec and New-Brunswick who have reached the age of majority in their province or territory of residence at the time of entry and have a valid email address.

EXCLUSIONS: Employees, representatives and/or agents of the IGA Ambassadors and Influencers Contest Organizer, prize suppliers and their advertising or promotional agencies, and any other entity involved in the design, production, implementation, administration or execution of the Contest (collectively, the "**Parties**"), as well as any person with whom such Excluded Entrant is domiciled or any member of his or her immediate family (each, an "**Excluded Entrant**"), are not eligible to participate in the Contest. For the purposes of these Contest rules (the "**Rules**"), the term "immediate family" includes an excluded entrant's parent, brother, sister, child, husband, wife or common-law partner. For clarity, an eligible Participant who is not an Excluded Entrant is hereinafter referred to as a "**Participant**".

Each participant must participate exclusively on his or her own behalf and for his or her own personal benefit.

HOW TO ENTER AND PARTICIPATE

NO PURCHASE NECESSARY

Internet access and a valid email adress are required to register and enter the Contest (the "Entry").

To enter the Contest, visit The Travelling Jar's website <u>https://fondsecoiga.org/the-travelling-jar/</u>, click on the **contest** button and follow the on-screen instructions to complete the entry steps.

By entering the Contest you agree to be contacted by Earth Day regarding your participation in the Contest. To be eligible for the Contest, your Entry must be submitted and received during the Contest Period. All eligible Entries submitted and received during the Contest Period will be included in the prize draw.

The Contest Organizer reserves the right to delete, erase, hide and/or edit any posted material at any time without notice. It does not endorse any material posted, stored or uploaded by entrants or any third party, and assumes no responsibility for such material or for any loss or damage thereto.

You understand that you are providing your personal information to Earth Day Canada. The personal information you provide will be used by the Contest Organizers and its partners for the purpose of administering and managing this Contest, and subject to the uses you have authorized in connection with your Entry. Any questions, comments or complaints in connection with this Contest should be directed to Earth Day Canada.

PRIZES AND APPROXIMATE RETAIL VALUE

A total of five (5) prizes will be offered in this Contest.

Each prize has a value of 570\$ and consist of one (1) pressure cooker, one (1) canning kit, five (5) reusable freezing bags, one (1) dehydrator, one (1) lactic fermentation kit, one (1) IGA gift card valued at a hundred dollars (\$100).

The total value of all prizes offered in this Contest is one thousand dollars (\$3000).

The Prize will be awarded by the Contest Organizer.

Each prize must be accepted as awarded and may not be transferred, assigned or redeemed for cash (except as expressly permitted by the Contest Organizer in its sole discretion). No prize substitutions will be made, except at the discretion of the Contest Organizer. One prize will be awarded per social network only to those who complete all steps of the contest on The Travelling Jar website and respond within seven (7) days to messages sent by Earth Day Canada following the drawing of their name in the prize draw.

SELECTION OF WINNERS

The draw will take place on October 10, 2023 at 2:00 p.m. (ET) at the offices of Earth Day Canada located at 5818 St. Laurent Boulevard, H2T 1T3, Montreal, Quebec, during which five (5) participants will be selected electronically and at random from among all the Entries collected or sent and received during the Contest Period, in accordance with these Rules.

ODDS OF WINNING

The odds of winning depend on the number of eligible entries submitted and received during the Contest Period in accordance with these Rules. Each person may enter the Contest once.

CONTACT OF SELECTED ENTRANTS

The Contest Organizer, or a designated representative, will make at least two (2) attempts to contact the selected entrants via email, using their email address as used to enter this Contest. If, after seven (7) days following the Draw Date, any of the selected entrants cannot be contacted, or if the notification sent to the selected entrant is returned as undeliverable, the selected entrant will, at the sole discretion of the Contest Organizers, be disqualified (and forfeit all rights to the prize in question). In such event,



the Contest Organizers reserve the right, in their sole discretion and if time permits, to randomly select another eligible entrant from the remaining eligible Entries (in which case, the provisions set forth in this section will apply to the newly selected entrant).

BEFORE BEING CONFIRMED AS A PRIZE WINNER, each selected entrant will be required to: (a) provide a first and last name and a valid mailing address in order for the Provider to mail the prize.

If the selected entrant: (a) fails to respond within seven (7) days to messages sent by Earth Day Canada, (b) cannot accept (or refuses to accept) the prize as awarded for any reason and/or (c) is found to be in violation of these Rules (as determined by the Contest Organizers in their sole discretion), he/she will be disqualified (and forfeit the prize) and the Contest Organizers reserve the right, in their sole discretion and time permitting, to randomly select another eligible entrant from among the remaining eligible Entries received (in which case, the provisions of this paragraph will apply to the new selected entrant).

Limit of one (1) prize per Participant per household.

Each winner consents to the publication, reproduction or other use of his/her name and statements in connection with the Contest and any materials and photographs by or on behalf of the Contest Organizers for publicity or other promotional or commercial use by or on behalf of the Contest Organizers in any existing or future media, including print, radio, television and the Internet, without further notice or compensation.

All Entries become the property of the Contest Organizer. The Contest is subject to all applicable federal, provincial and municipal laws and regulations.

The decisions of the Contest Organizer are final and binding in all matters relating to this Contest, including any decisions regarding the validity or disqualification of Entries or entrants. Any person found to be in violation of these rules for any reason is subject to disqualification at any time at the sole discretion of the Contest Organizer.

The Contest Organizer reserves the right, subject only to the approval of the Régie des alcools, des courses et des jeux (the "**Régie**") in Quebec, to withdraw, amend or suspend this Contest (or to amend these Rules) in any way, due to an error, technical problem, computer virus, bug, tampering, unauthorized intervention, fraud, technical failure or any other cause.

Any attempt to deliberately undermine the legitimate operation of this Contest (in the sole discretion of the Contest Sponsor) is a violation of criminal and civil laws. The Contest Organizer reserves the right to seek remedies and damages to the fullest extent permitted by law. The Contest Organizer, with the consent of the Régie, reserves the right to cancel, modify or suspend this Contest, or to amend these Rules in any way, in the event of an accident, printing error, administrative error or any other error whatsoever, or for any other reason, without prior notice or obligation.

The Contest Organizer reserves the right, in its sole and absolute discretion, to modify without notice the Contest schedule or any of the dates indicated in these Contest Rules, when

necessary, in order to verify the compliance of any entrant or Entry with these Contest Rules, or due to technical problems or any other circumstances which, in the opinion of the Contest Organizer and in its sole discretion, may affect the proper administration of the Contest in accordance with these Contest Rules, or for any other reason.
